

## The Voter's Choice Act: changing the way we vote

Starting in 2018, Napa County will be one of the first to implement the Voter's Choice Act; a new law that expands voters' choices as to where, when and how to vote.

All registered voters will receive their ballot in the mail about a month before the election. Instead of going to your old polling places, you will have **3 choices** for how to vote:



### **Vote by Mail**

You can mail your ballot starting as soon as you receive it.



### **Drop Box**

You can drop off your ballot at any secure Drop Box starting as soon as you receive it. No postage required at Drop Boxes.



### **Vote Centers**

You can go to any Vote Center in your county to vote in person. Vote Centers will be open for **up to** 11 days in a row through 8 PM on Election Day. At every Vote Center you can: vote, register and vote the same day, drop off your ballot, use an accessible voting machine, and get help and voting materials in multiple languages.

## Napa County's Election Plan

The new law requires Napa County to get community input on the new election plan, called the Election Administration Plan. The plan must carefully consider how to make voting convenient and easy to access for everyone, and how to educate people about the changes.

You have the best information about where you and your neighbors will be comfortable voting and what you and your neighborhoods need. Review your county's plan and use the attached form to offer feedback.

## The Voter's Choice Act Community Review Guide

The county's new election plan will describe a number of topics. Feel free to read the entire plan or skip to the sections that matter the most to you. Use the attached form to write down your thoughts and suggestions. It's ok to leave areas blank if you don't have an opinion on something.

Below are a few topics that you will see covered in the Election Administration Plan:

- Vote Center locations
- Ballot Drop Box locations
- Public education plans
- Media outreach ideas
- Support and tools for voters with disabilities
- Assistance for voters who speak a language other than English

The locations of Vote Centers and Ballot Drop Boxes are very important because they need to be as easy as possible for everyone to access.

**As you review the Vote Center and Ballot Drop Box locations think about whether these are convenient or close to:**

- Popular community locations
- Free and accessible parking
- Communities of people with disabilities
- Communities where people speak a language other than English
- Public transportation
- Low-income communities
- Neighborhoods where not many people own cars
- Geographically isolated populations (like rural areas)
